This report serves to summarize the implementation of the components set forth in the Public Participation Plan (PPP) prepared by Environmental and Energy Solutions, Inc. (EES) on behalf of NYC-HH Bellevue Hospital and approved by the New York State Department of Environmental Conservation (NYSDEC), with respect to the installation of two gas-fired Cogen Engines at Bellevue Hospital, assigned DEC ID: 2-6206-00032/00004.

1. Public Outreach Activities

Bellevue Hospital actively engaged with the public and provided opportunities for citizens to be informed about and involved in the review of the proposed power plant project.

Pursuant to the Public Participation activities included in the approved PPP, the project owner completed the following activities.

To inform the public about the proposed permit modifications and address CP-29 requirements, Bellevue reached out to the affected communities and the public about the project, providing them with the details to join the teleconference meeting as well as contact information for an opportunity to comment during the NYSDEC environmental permit application review process.

The stakeholders of interest and/or affected by the project that were contacted, records of the outreach are in Appendix C and the public notices are included in Appendix A and B. The Meeting Notice and a reader-friendly project fact sheet were mailed to the public two weeks prior to the meeting date, the contact tracking spreadsheet shows when, where and how. The list includes local government and elected officials; businesses, organizations, schools, residents, and occupants who live or work within a 0.5-mile radius from the project area. Since Bellevue is surrounded by a large population of Spanish speakers, Bellevue published the Meeting Notice in El Diario NY on 9/13/2023 and the Manhattan Express Newspaper on 09/15/2023 (Appendix E) and the fact sheet is provided in English and Spanish.

Relevant documents to the permit application and project information were published online for the community to access and review information about the project at any time. The website also served as point of contact for public to comment or get contact information. The website was continuously monitored for comments before the meeting and will continue to be open.

2. Summary of Virtual PPP Meeting

Bellevue Hospital hosted a tele/videoconference meeting via Webex on September 28, 2023, at 6:30 PM. The meeting notice (Appendix A) had explicit instructions on how to join online through Webex and/or by phone and contact information for Bellevue officials.

Bellevue conducted a public Webex meeting and participants' attendance was digitally recorded (Appendix D). Bellevue presented the project's background, scope of work, environmental and community impact, and shared contact information and period for public commentary. After the presentation, the floor was opened to the public for questions, comments, and concerns. The following

questions were received:

Michael Smook, Local Resident

Question: Is there any federal funding from the Biden Administration paying for the project?

Response: The project will be paid for through municipal funding.

Question: Is the installation of Cogen Engines a New York City Health and Hospital wide project?

Response: The installation of Cogen engines is a Bellevue specific project since there are specifications and requirements that must be met to permit the use of Cogen engines.

There were no public concerns raised at the virtual meeting or to the project liaison and there have been no changes (due to public concern) made to the project. The website repository and project liaison are available to the public until the permit issued, the website will be constantly updated and monitored.

What is the Proposed Project?

The Proposed Project will involve the installation and operation of two (2) new natural gas fired co-generation engines – Caterpillar G3516H, each with 1982 kW rating.. To implement the proposed project, NYC Health and Hospitals has submitted an application for an Air State Facility Permit Renewal with Modifications to the New York State Department of Environmental Conservation (NYSDEC) to permit the installation and operation of these engines in addition to their current permit that covers participation of six (6) generators in Coordinated Demand Response Programs (CDRP). The nature of the project is to enable the Hospital to generate its own heat and electricity, offering greater energy independence by moving a portion of the load off the grid. The purpose of this fact sheet is to inform the public about this proposed project and to involve the community during the NYSDEC permit application review process.

Why does NYC HHC need to Install Two Cogen Engines?

The primary goal of this project is to provide Bellevue Hospital with a 4MW Combined Heat and Power (CHP) system capable of meeting two tasks: (1) Delivering on-site power to the facility in the event of an electrical utility outage for an extended amount of time, and (2) Reducing energy costs and increasing energy efficiency for the facility.

How might the project affect the surrounding community?

The installation of these cogeneration units will lead to an increase in air emissions on the Bellevue Hospital Site, but will reduce the facility's overall energy use. Air quality modelling has been performed to ensure the addition of these units will not impact ambient air quality. Installation of these new, state-of-the-art engines will create resiliency for the hospital in the case of extreme weather events or power outages, ultimately benefitting the members of the community who utilize the hospital's services. Participation in Coordinated Demand Response Programs will also help reduce strain on the power grid to help New York City avoid blackouts.

¿En qué consiste el proyecto propuesto?

El proyecto propuesto implicará la instalación y operación de dos (2) nuevos motores de generación combinada a gas natural: Caterpillar G3516H, cada uno con una potencia nominal de 1982 kW. Para implementar el proyecto propuesto, NYC Health and Hospitals ha presentado una solicitud de Renovación de Permiso de Instalación Aérea del Estado con Modificaciones al Departamento de Conservación Ambiental del Estado de Nueva York (New York State Department of Environmental Conservation, NYSDEC) para permitir la instalación y operación de estos motores además de su permiso actual que cubre la participación de seis (6) generadores en Programas de Respuesta Coordinada a la Demanda (Coordinated Demand Response Programs, CDRP). La naturaleza del proyecto es permitir que el Hospital genere su propia energía térmica y electricidad, brindando una mayor independencia energética al reducir parte de la carga de la red eléctrica. El propósito de esta hoja de datos es informar al público sobre este proyecto propuesto e involucrar a la comunidad durante el proceso de revisión de la solicitud de permiso del NYSDEC.

¿Por qué NYC HHC necesita instalar dos motores de cogeneración?

El objetivo principal de este proyecto es proporcionar al Bellevue Hospital un sistema combinado de calor y energía (Combined Heat and Power, CHP) de 4MW capaz de cumplir dos tareas: (1) Proporcionar energía en el sitio en caso de un corte prolongado en los servicios eléctricos públicos y (2) Reducir los costos energéticos y aumentar la eficiencia energética de las instalaciones.

¿Cómo podría afectar el proyecto a la comunidad cercana?

La instalación de estas unidades de cogeneración resultará en un aumento de las emisiones de aire en los alrededores de Bellevue Hospital, pero reducirá el uso general de energía de la instalación. Se ha elaborado un modelo de calidad del aire para asegurarse de que la adición de estas unidades no afectará la calidad del aire ambiental. La instalación de estos nuevos motores de última generación creará resiliencia para el hospital en caso de eventos climáticos extremos o cortes de energía, lo que en última instancia beneficiará a los miembros de la comunidad que utilizan los servicios del hospital. La participación en los Programas de Respuesta Coordinada a la Demanda también ayudará a reducir la tensión en la red eléctrica para evitar cortes de energía en la Ciudad de Nueva York.
