These data are compiled from documented patient events that involved naloxone administration, which is a standard, presumptive component of CHS emergency response protocols. They may also include patient encounters where a wide range of clinical presentations that can mimic overdose are referenced.

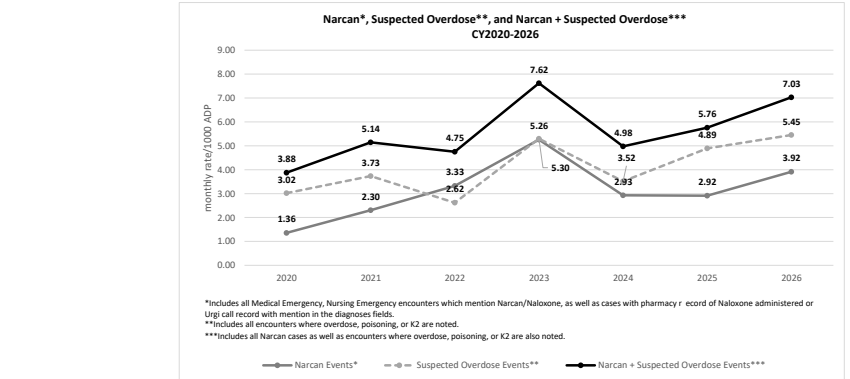
